SUBJECT: ESEA TITLE I PARENT INVOLVEMENT

The School District's New Compact for Learning Plan for Participation that involves all parents is the parental involvement policy that applies to all parents. This draft clarifies Title I parent involvement.

Involve Parents in an organized ongoing and timely way in planning, review, and improvement of Title I programs, including the school parental involvement policy, and access to participation on Site Based Teams through the election/selection process as written in the New Compact for Learning Plan for Participation.

- d) A description and explanation of the curriculum in use at the school, the forms of assessment used to measure student progress, and the proficiency levels students are expected to meet,
- e) Opportunities for regular meetings, such as Title I Annual meetings, PTO, School Site Based Team, and Curriculum Fair to formulate suggestions, share experiences with other parents, and participate as appropriate in decisions relating to the education of their children if parents express an interest in doing this; and
- f) Timely responses to the suggestions made by parents that have been offered in meetings such as those described in (e) above.

Parent comments on the Compensatory Program Plan will be submitted if the Plan is not satisfactory.
